The CE, NH, Raipur submitted the proposal of M/s. HPCL vide letter no. 938/W/CE/NH/Raipur, dated 10/04/2018 to this office for above subject proposal. The applicant M/s. HPCL has sought relaxation as per Ministry Guideline No.RW/NH-33023/19/99-DO.III dated 24.07.2013. There are two temporary roads at distance of 141m & 208m. However as per Ministry Standards and specified at in para 4.5.1, 1 (ii) is filling short of Ministry's circular date 24.07.2013. The justification towards relaxation is placed at [annexure I].

2. As per Ministry OM vide No.RW/NH/33023/19/99-DO.III date 16.03.2016, the Highway Administration will make available the relaxation proposal of Oil company for public comments, and the comments will be invited for a period of 60 days from the day of uploading. According, the above relaxation proposal is being upload in website of Ministry and Road Transport and Highways (www.morth.nic.in).




