Rithik Sizing Mills India Private Limited, Erode - Approval requested - Reg

- 1). The subject proposal is requesting permission for laying proposed 101.6mm Dia GI Pipe on NH-544 by Open Excavation from Km 65/733 to Km 66/254 in the project of Kumarapalayam to Chengapalli section of NH-544 in the State of Tamil Nadu.
- 2). M/s. Rithik Sizing Mills India Private Limited, Erode has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Rithik Sizing Mills India Private Limited, Erode will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
