Bids must be accompanied by non-refundable tender fee as indicated in Column 5 of the above table, in the form of Demand Draft in favour of "Executive Engineer, National Highway Division, Gandhidham", payable at Gandhidham from any Nationalized/ Scheduled Bank except Co-operative Bank. Demand draft issued after the date of submission of Bids i.e. **dt.12/02/2019** will not be considered or accepted. Last date of Receipt of tender fees in office is **dt. 19/02/2019** during office hours i.e. upto 18.10 hrs.

Bid Security i.e. EMD for the works mentioned at Sr. No. (1) in the column 4 of the above table shall be drawn in the form of in the form of FDR in favour of "Executive Engineer, National Highway Division, Gandhidham" from any Nationalized / Scheduled Bank except Co-operative Bank shall be valid up to 180 Days. FDR issued after the last date of submission of tender will not be considered as valid or accepted in any case. Last date of getting E.M.D. is dt. **19.02.2019**, E.M.D. Exemption certificate can also be accepted.

If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
6. The rates are inclusive of cost of traffic management during construction. Contractor shall provide road signage, bollards, boards, gunny bags, sheets etc. for safety of traffic during construction period, which will be incidental to work.
