SUB: Proposal seeking ROW permission for Statutory Approval for laying of 132KV U/G Cable Earthing Continuity Cable, FOAC Cable **along NH-48 from Km 483+200 to Km 486+228 on LHS** towards Udaipur-Ahmedabad section of NH-48 & crossing of 132KV Transmission Line at **Km 483+200 on LHS** to RHS towards Udaipur to Ahmedabad National Highway in the state of Gujarat.


