Sub: 4-laning of Madhya Pradesh/Maharashtra Border Nagpur Section of NH-7 from Km.652.000 (New Km.653.225) to Km.729.000 including construction of Kamptee - Kanhan and Nagpur Bypass and Maintenance of already 4 -laned sections from Km.14.585.000 to Km.36.600 NH-7 (Nagpur-Hyderabad Section) in the State or Maharashtra under NHDP Phase-II on DBFOT Basis- Proposal for permission for laying of 11 KV 95 sqmm UG cable across and along the highway (Jabalpur-Wardha) near Jagdamba stone crusher 11 KV Chikna Feeder and Jabalpur-Wardha Highway near Prerna College of 11 KV Adyali Feeder under RDSS AG FA Scheme under Congress Nagar Division - Approval-Reg.

 - Crossing 11KV underground line at km 733.750 & km 739.010.
 - 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
