2. The Right of Way in the stretch of NH proposed for laying Water pipe line is varying from 19.00m to 37.00m. The carriageway width of stretch Km 271/065 to Km 271/400, Km 271/150 to Km 271/400, Km 272/00 to Km 273/990 & Km 272/00 to Km 274/065 (Sathyamangalam to Coimbatore Section) is 17.00m. Further, mentioned that, the Commissioner, Municipal Office, Jawahar Main Road, Punjai Puliampatti, Sathyamangalam, Erode will also restore the ROW surfaces to its original
