**Sub:** NHAI-PIU-NSK - Widening of existing 2 lane carriage way to 4/6 lane carriageway configuration for Dhule - Pimpalgaon (Km 265.00 to Km 380.00) section of NH-3 in the State of Maharashtra - M/s. Godrej Agrovet Ltd.'s proposal for laying Overhead 11 KV HT Electrical Line from Km. 326+800 to Km. 368+350 along NH-3 and Underground Crossing of 11 KV HT Electrical Line at Km. 368+350 across NH-3.

M/s. Godrej Agrovet Ltd. vide letter cited above submitted Proposal for laying Overhead 11 KV HT Electrical Line from Km. 326+800 to Km. 368+350 along NH-3 and Underground Crossing of 11 KV HT Electrical Line at Km. 368+350 across NH-3 for approval of the Competent Authority, Highway Administration.
