Proposal for ROW Permission for laying proposed 6" dia Steel Gas Pipeline along NH-47 (Old NH-59) from Km 190+921 to Km 192+523 (Godhra-Dahod-Indore) from TOP (On proposed 6" dia steel Gas Pipeline) to Shakarnagar, Taluka-Dahod, District-Dahod (Dahod GA) in the state of Gujarat.


