

Reg. Proposal for ROW permission for laying 18"OD X 0.25" WT MS LPG Pipeline along with OFC across Vadodara-Delhi National Expressway NH-148N (Delhi-Vadodara Expressway section) at Km 391+639 in Village Dodka, Tal-Vadodara, Dist-Vadodara in the state of Gujarat.
