Ten Thousand Rupees Only) shall be paid in the form of D.D. of any Nationalized/scheduled banks payable at MADHEPURA in favour of Executive Engineer N.H Division, MADHEPURA. and Bid Security in the form of BG only. Original D.D. and Document of Bid Security will have to be deposited in the office of Chief Engineer (North) wing, N.H. R.C.D. Bihar Patna / C.E.-cum- R.O. (b) Bid Security shall be in favour of Superintending Engineer, NH Circle, PURNEA in the form of a bank Guarantee issued by Nationalized Bank or a scheduled Bank in India having a net worth of at least Rs. 1000 Crore in the format at Appedix-II (The Bank Guarantee) and having a validity period of not less than 180 (One Hundred Eighty) days from the bid due date.

4. For participating in the above RFP process, the contractors shall have to obtain user ID, password and digital signature may be issued to them. This will enable them to access the website (<u>https://eprocure.gov.in/eprocure/app</u>) and download/ participate in E-EPC tender.

5. The blank RFP documents can be downloaded from our website <u>https://eprocure.gov.in/eprocure/app</u> where electronic RFP form is provided.

6. Bidders/Contractors can access RFP documents on the website, fill them and submit the completed RFP document into Electronic RFP on the website itself. Bidders/ Contractors shall attach scanned copies (PDF, JPG) of all the required RFP papers, i.e. BID & the certificates as required in Eligibility criteria.

7. All the uploaded documents shall have the signature of bidder or their authorized signatories. The scanned copies should be of the original papers and certificates.

8. The bidder is requested to check their file size of uploaded documents at the time of submission & they should ensure that work file is uploaded. If they feel that the complete file is not uploaded then they should click on cancel & update the same before submission. The bidders should satisfy themselves of Download ability/visibility of the scanned & uploaded file by them.

9. The bidder is directed to zip their files using Win Zip software only. Other formats of zipping will not be accepted and will be rejected.

10. The bidder must use MS Office-2007 or lower version.

11. File size should be less than 5MB and should be in MS Word, Ms Excel, PDF and JPEG formats.

12. No claim shall be entertained on account of disruption of internet service being used by bidders. Bidders are advised to upload their bids well in advance to avoid last minute technical snags.

13. Corrigendum / Addendum / Corrections, if any will be published on the website. The completed RFP document should be submitted at the above address on or before 17:00 hrs. on 05-09-2019. RFP will be evaluated first. The Financial bid of the successful bidders in RFP only will be opened. After the evaluation of financial bid the agreement for execution of works, if any, would be executed between the successful bidder & the respective State Government. However, the employer/Engineer reserves the right to reject bid of any applicant without assigning any reason.
