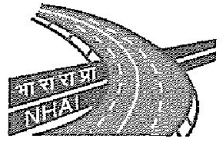

Sub.:- Construction of Six-lane access controlled highway (NH-152D) starting from junction with NH-9 (Rohtak-Jind section) near Kharkara to Junction with NH-334B (Charkhi Dadri- Jhajjar section) near Charkhi Dadri (Ch. 131+000 to 165+000; length 34 Km) on EPC mode under Bharatmala Pariyojna in the State of Haryana (Pkg-6) – Permission to lay Sultanpur-Jhajjar-Hisar Natural Gas pipeline along with OFC across under construction road b/w Ch. 142.800 to 143.000 at village- Kherari, Tehsil Kalanaur, Dist.- Rohtak – reg.
