Bids must be accompanied by non-refundable Tender Fee as indicated in Column 5 of the above table, in the form of Demand Draft in favour of "Executive Engineer, National Highway Division, Rajkot, payable at Rajkot from any Nationalized / Schedule Bank except Co-Operative Bank. Demand Draft issued after the last date of submission of Bids will not be considered or accepted. Last date of Receipt of Tender Fees in Office is within 7 days of last date of submission during office hours i.e. up to 18.10 hrs.
4. Bid Security i.e. EMD for the works mentioned at Sr.No.1 to 3 in the Column No.4 of the above table shall be drawn in the form of FDR in favour of "Executive Engineer, National Highway Division, Rajkot from any Nationalized / Scheduled Bank except Co-Operative Bank shall be valid up to 180 days. FDR issued after the last date of submission of tender will not be considered as valid or accepted in any case. Last date of getting the original document of EMD is within 7 days from the last date of submission of the tender.
5. Bids must be submitted online only at e-tendering portal of CPP portal <https://eprocure.gov.in> as per the date and time given in the NIT / Tender document on e-portal and bids received online will be opened as per the date, time venue given in the NIT / Tender document on e-portal in the presence of the bidders who wish to attend.
6. No proposal will be accepted in physical form except Bid Security (EMD) , Tender Fee and Other documents. The bidders have to submit their Bid Security (EMD), Tender Fee and Other documents in hard copy (original) sent through R.P.A.D. only to the office of the Executive Engineer, National Highway Division, Dr.Rajendra prasad Road, Rajkot, PIN-360 001 (Phone No. 0281-2446605) so as to reach within 7 days from the last date of submission of the tender.
7. I) Before submission of online bids, bidders must ensure that scanned copy of all the necessary documents have been attached with bid.
 II) The department will not be responsible for delay in online submission due to any reason whatsoever.
 III) All the information required for bid must be filled in and submitted online.
 (IV) All documents / papers uploaded/submitted by the bidder must be legible.
 Uploaded documents of valid successful bidder will be verified with the original documents before signing the Agreement. The valid successful bidder has to provide the originals to the concerned Authority on receipt of such letter, which will sent through registered post / E-mail.
8. Following may be noted.
 I) Registration should be valid of submission of bids.
 II) Bids can be submitted only during the validity of their registration.
 III) The amendments / clarifications to the Bid document, if any will be hosted on the CPP portal <https://eprocure.gov.in>
9. Following Documents must be required to be submitted with the Tender by On-line only.
 1. Scanned copy of Tender Fee (Only CTS Demand Draft)
 2. Scanned copy of Bid Security (EMD) or EMD Exemption Certificate is also accepted.
 3. Copy of current registration certificate as mentioned in the table above column No.6.
 4. Solvency Certificate for the current year as per the tender document.
 If bidder fails to provide proof of assured availability of above required documents he will be disqualified for the proposed work.
