The Manager (CR), M/s Torrent Gas Pvt. In this regard, RO-UP(West), NHAI, Lucknow vide letter no. 19001/1/RO-W-UP/Utility/19471 dated 21.03.2023 and no. 18001/1/RO-W-UP/H-M/NH-09/Ch. 142+440 to 144+300/OH/NOC/2154 dated 23.05.2023 has also issued directions to put out the application of Public and Industrial Utility Services along and across National Highway in the public domain for 30-days for seeking public comments at PIU Level.
