Sub: NHAI-PIU-NSK- Six Laning of Pimpalgaon - Nashik - Gonde Section of NH-3 from Km 380.00 to 440.00 in the State of Maharashtra - **Proposal for Crossing of 1200mm diameter Sewage Pipeline at Km. 414.130 (between Pier No. 22 & Pier No. 23) across NH-3.**

Executive Engineer, PHED- (Sewerage), Nashik Municipal Corporation, Nashik vide letter cited above has submitted proposal for Laying / Crossing of Sewage Pipeline along / across NH-3 for approval of the Competent Authority, Highway Administration.

2. From the submitted proposal, it is observed that, the Crossing of 1200mm diameter Sewage Pipeline across NH-3 (Pimpalgaon-Nashik-Gonde Section) is proposed at Km. 414.130 (between Pier No. 22 & Pier No. 23).

3. As per Para-4 of Ministry Circular No. RW/NH-33044/29/2015/S&R(R), Dtd. 22.11.2016, the Highway Administration shall put out in the Public Domain for 30 days for seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
