Sub:- Proposal for permission to laying 11KV UG cable 3 x 300 Sq.mm from CIFT junction to Maritime University through NH 966B from Chainage 0/000 to 2/700 - reg

The proposal is seeking permission for laying 11KV UG cable 3 x 300 Sq.mm from CIFT junction to maritime University through NH 966B from Chainage 0/000 to 2/700 by KSEB submitted to this office vide EE, PWD NH Division, Muvattupuzha letter No. DB-141/2018 dated 05.07.2024 accordance with Ministry's latest guidelines dated 22.11.2016.

3. M/s Kerala State Electricity Board has proposed for laying laying 11KV UG cable 3 x 300 Sq.mm from CIFT junction to maritime University through NH 966B from Chainage 0/000 to 2/700 on NH-966B with HDD method for crossings.

4. M/s Kerala State Electricity Board has furnished an undertaking that, they will shift the utility at their own cost if required for expansion of reach by MORTH/NHAI/PWD or any other Highways authorities within the time frame prescribed by MORTH/NHAI/PWD. Further, it is also mentioned by KSEB that the proposed laying 11 KV UG cable will not affect the design, stability, traffic safety and future improvement of proposed stretch. In addition, all the undertakings as prescribed in the checklist has been furnished by KSEB.

5. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R (R) dated 22.11.2016, the application will be made available for public comments and the comments will be invited within 30 days from the date of uploading in the Ministry's web site.
