Commissioner & Administrator, Dhule Municipal Corporation, Dhule vide letter cited above has submitted Proposal for Laying/Crossing of Sewer Pipeline along/across ROW of NH-3 (Dhule-Pimpalgaon Section) of NH-3 for approval of the Competent Authority / Highway Administration.

- 2. From the submitted proposal, it is observed that, Laying & Crossing of Sewerage Pipeline is proposed along/across ROW of NH-3 (Dhule-Pimpalgaon Section) from Km. 261.798 to Km. 264+010 on LHS (Length 2212m), Km. 264+010 to Km. 264+674 on BHS (Length 1328m), Km. 264+674 to Km. 265+520 on LHS (Length 846m), Km. 266+646 to Km. 267+138 on LHS (Length 462m) (Total Length 5.391 Km) & 1 No. Crossing at Km. 262.849 across NH-3.
- 3. As per Para-4 of Ministry of Road Transport & Highways (MoRT&H) Circular No. RW/NH-33044/29/2015/S&R(R), Dtd. 22.11.2016, the Highway Administration shall put out in the Public Domain for 30 days for seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
- 4. In view of the above, the claims /objections of affected public is hereby invited with reference to Ministry's Circular Dtd. 22.11.2016 for the above mentioned proposal.
