SUB: Short Term Improvements and Routine maintenance of Surat - Dahisar section from Km. 263.000 to 381.000 on Nh-48 in the State of Gujarat.

- Proposal seeking ROW permission for 90 mm dia MDPE pipelines to set up a Piped Natural Gas distribution network in Jalalpore Taluka & Surrounding Area of Navsari District - Pipeline Laying parallel to National Highway - 48 (old Nh-8) (Bharuch - Mumbai) from (1) NH Ch. 275.588 Km to 277.650 Km for length of 62 Mtr (LHS) & (2) NH Ch. 276.740 Km to 277.230 Km for Length of 490 Mtr (RHS) near Village Vesma in Taluka Jalalpore, District; Navsari in the state of Gujarat.


