Reg. Permission for laying of 10" dia. steel oil pipeline across NH-48 at Km. 21+700 near Village Bareja. Tal-Daskroi, Dist-Ahmedabad on Ahmedabad-Vadodara section of NH-48 in the state of Gujarat.
