SUB: Six Laning of Ahmedabad to Vadodara section of NH-8 from Km 6+400 to Km 108+700 (Length 102+300 Km) in the state of Gujarat and Improvement of Ahmedabad-Vadodara Expressway from Km 0+000 to Km 93+302 in the state of Gujarat (Length 93+302 Km) under NHDP Phase V on DBFOT Toll Basis.

- Permission seeking ROW permission for laying Drinking Water Pipeline across NE-1 at Km 76+300 (with casing pipe of 250mm dia) and Km 77+880 (with casing pipe of 400mm dia) at Taluka-Savli, District-Vadodara on Ahmedabad-Vadodara section of NE-1 in the state of Gujarat.

The Project Director, NHAI, PIU-Ahmedabad vide letter u/ref.(1) has recommended the revised proposal submitted by Executive Engineer M/s. GWSSB-Vadodara vide their office letter u/ref.(2), in compliance to the PD, PIU-Ahmedabad office letter u/ref.(3), seeking ROW permission for laying Drinking Water Pipeline across NE-1 at Km 76+300 (with casing pipe of 250mm dia) and Km 77+880 (with casing pipe of 400mm dia) at Taluka-Savli, District-Vadodara on Ahmedabad-Vadodara section of NE-1 in the state of Gujarat.

2. Now, as per Ministry vide OM No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the Highway Administration will make available the proposal seeking permission for utility laying for public comments for **30 days** on the ground of general public interest for seeking claims and objections.
