1. The Executive Engineer, National Highway Division, Rajkot invites online bids on EPC mode of contract for Strengthening work of NHs detailed in the table given below. The bidders are advised to examine carefully all instructions contained in the Bid Document.

IST). Bids must be submitted online only in electronic mode through CPP portal of NIC <http://eprocure.gov.in> by Bid Due date i.e. on or before 03/09/2019 (up to 12 Hrs. IST) and bids received online will be opened on 04/09/2019 at 12.00 Hrs. IST.

3. A Pre-Bid Meeting will be held on date 26/06/2019 time 12.00 Hrs. at the office of the **Superintending Engineer, National Highway Circle, 1<sup>st</sup> Floor, 'A' Block, patnagar Yojna Bhavan, Sector -16, Gandhinagar-382016 (Gujarat) (Phone No. 079-23222235)** to clarify the issues and to answer questions on any matter that may be raised by the perspective bidders.
4. Those Applicants who are eligible/qualified as per the RFP finalized by the Ministry upto the last date of bid submission, are invited to participate in the submission of financial proposal ("the BID") at this bidding stage for the aforesaid projects in accordance with the RFP along with updated status pursuant to Clause No. 2.1 & 2.2 of RFP document and Annexure -I of Appendix-I A, of RFP document in case their eligibility limit is not less than the estimated cost of a particular project.
5. The bidder shall furnish as part of its BID, a BID Security referred to in Clauses 2.1.6 and 2.1.7 of RFP in the form of a FDR or Bank Guarantee issued by nationalized bank, or a Scheduled Bank in India having a net worth of at least Rs.1.000 Crore (Rs. One Thousand Crore Only), in favour of the "Executive Engineer, National Highway Division, Rajkot" in the format at Appendix-II of RFP (the "Bank Guarantee") and having a validity period of not less than 180 (one hundred eighty) days from the BID due date, inclusive of a claim period of 60 (sixty) days, and may be extended as may be mutually agreed between the authority and the bidder from time to time. In case the Bank Guarantee is issued by a foreign bank outside India, confirmation of the same by any nationalized bank in India is required. For the avoidance of doubt, Scheduled Bank shall mean a bank as defined under Section 2(e) of the Reserve Bank of India Act, 1934. Any Bid not accompanied by the bid security shall be summarily rejected by the Authority as non-responsive.
6. Bid Through any other mode shall not be entertained. However, Bid Security, Documents fee, Power of Attorney and joint bidding agreement shall be submitted physically by the bidder on or before 03/09/2019 up to 18.10 Hrs. IST at the office of the **Executive Engineer, National Highway Division, Dr. Rajendra Prasad Road, Nr. Kashivishwnath Temple, Rajkot-360001 (Phone No. 0281-2446605) by RPAD / Speed Post A.D.** If the office happens to be closed on last date of submission of bid security in hard copy as specified, the bid security will be received on the next working day at the offices mentioned above.

In case, BID Security is not received within specified time, the bid shall be considered non-responsive and shall not be downloaded/evaluated.

7. Please note that the Authority reserves the right to accept or reject all or any of the BIDs without assigning any reason whatsoever.
8. The prospective bidders who do not possess Digital Signature Certificate (DSC) may get the same issued from approved agencies.
9. For any amendment / corrigendum will be uploaded on portal of (e-procurement through CPP portal of NIC <http://eprocure.gov.in>). Bidders will bound to follow all amendment/ corrigendum and are requested to check portal (e-procurement through CPP portal of NIC <http://eprocure.gov.in>) regular basis for any updation before the last date and time of submission the tender.
