- 1). The subject proposal is requesting permission for laying of Water supply Pipe Line across the road by HDD Method at Km 285/600 - 60m under the providing water supply scheme to 756 rural habitations in Aravakurichi and K.Paramathi Unions in Karur District in the project of Namakkal to Karur section of NH-44 in the State of Tamil Nadu.
- 2). The Executive Engineer, Tamilnadu Water Supply and Drainage Board, RWS Division, Karur has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. - 3). As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by the Executive Engineer, Tamilnadu Water Supply and Drainage Board, RWS Division, Karur will be made available for 30 days seeking public


