With reference to captioned subject and letter u/r (1) vide which DW&SD, Godda had submitted the proposal of water pipeline laying in the area of Pathargama Block to this office.

Accordingly, a site visit was conducted with authority, IE personal and applicant i.e. DW& SD, Godda, during site verification it was observed that ROW at that particular chainage was unavailable which was mentioned in water pipeline laying proposal whose details report was submitted by Independent Engineer vide letter u/r (3). Subsequently the proposal had been returned by this office to re-submit the proposal finding out some alternative route by letter u/r (4).

Further, The Applicant i.e. DW&SD has re-submitted the proposal u/r (5) and the Same has been examined by Independent Engineer in accordance with MoRTH Guidelines i.e. RW/NH-33044/29/2015/S&R(R) dt  $22^{nd}$  November,2016 and recommended vide its letter u/r (7) & (8).
