The Roads and Building Department, Government of Gujarat vide letter no. NHP-13-2022-1097-M dated 31/12/2022 has recommended the subject cited proposal for the permission for laying of PE water supply pipeline of 90 mm dia. with casing of 250 mm dia. of M/s. 
