

With reference to the above subject, the M/s.Telesonic Networks Ltd (Formerly Bharti Airtel Ltd) Bangalore has submitted their proposal for Horizontal Direct Drilling (HDD) and Open Trenching for Laying of Optical Fiber Cable (OFC) by adopting HDD/manual trenching method along "NH-150A from Lingasagur km 118.00 to Maski km 149.00 on LHS and from Hasmakal km 152.000 to Sindhnur km 171.000 on LHS for a total length of 50.00 Kms in the State of Karnataka by HDD method for providing the latest communication network to the public. Further stated the work shall be executed by their on self restoration basis at their own cost, cable shall be laid on the extreme edge of the road within ROW limits. If necessary manholes / inspection chambers shall be constructed along the proposed optical fiber cable route as per the enclosed detailed drawing and also assured that the restoration work shall be carried out with the satisfaction of Highway Department.

Further Assistant Executive Engineer N.H. Sub-Division, Hungund reviewed the proposal as per site conditions and submitted with a recommendation to accord permission for laying optical fiber cable along the NH-150A vide above cited reference (2).

The necessary documents as per the Ministry circular No.RW/NH-333044/27/2005-S&R(R) (Pt), dtd:-7-8-2013 and F.No.RW/NH-333044/29/2005-S&R(R) dtd:-22-11-2016. The M/s.Telesonic Networks Ltd (Formerly Bharti Airtel Ltd), Bangalore has furnished as below;

- 2)Agreement regarding granting of ROW permission for laying utility services on National Highways.

- 4)Under takings to adhere with the following conditions.

- i) We agree to lay the OF Cables at the outer edge of the ROW, in the utility corridor.
ii) We will be taking the layout marked in concurrence of Engineer before starting the work.
iii) We will do manual trenching work.
iv) We will take working pits approval from Engineer before starting excavation.
v) We will take precaution not to do any damages to bituminous layer during work or after completion of work.
vi) We shall ensure that excavated manholes are brought back to original condition on completion of work.
vii) We will remove all debris at site.
viii) We will accept the permission terms and period.
ix) We will submit the Bank Guarantee as required by NH.

- 6) Under taking for traffic movement will be managed by M/s. Telesonic Networks Ltd (Formerly Bharti Airtel Ltd) Bangalore during laying OF Cables.
7) Under taking for expenditure if any incurred by National Highway Department for repairing any damages caused to the National Highway, Maintenance or shifting of underground optical fiber cable will be borne by M/s. Telesonic Networks Ltd (Formerly Bharti Airtel Ltd) Bangalore.
8) Under taking for relocation of cable at their own cost in future during widening / improvement of National Highway.
9) Under taking against all damages and claims Clause (xxiv).
10) Single line diagram of proposed length.
