- (i) The successful bidder will be required to deposit the bid amount within 03 days by NTRP/demand Draft in f/o "Pay & Accounts Office (NH), Ministry of SRTH, Jam Nagar House, New Delhi."
- (ii) The delivery of the sold vehicle will be given only after the successful bidder submits documentary evidence in support of residential status (PAN Card/Driving License/Voter ID Card etc.) and the payment of bid amount.
- (iii) The sold vehicle shall have to be removed by the successful bidder within 24 hrs. on payment of bid amount at his or her own expenses.
- (iv) The vehicle will be disposed off on "as is where is basis".
- (v) The successful bidder will also be responsible for getting the Registration Certificate of the Vehicle transferred in his name at his own cost expeditiously within 15 days of getting delivery of the Vehicle. Copy of the documentary evidence for the same is to be provided to this office.
