COMPASSIONATE APPOINTMENT

(Status in MoRT&H)

Guideline followed: DoP&T vide its O.M. No. 14014/20/2012-Estt. (D) dated 16.01.2013 has issued consolidated instruction regarding the procedure to be followed while making appointments on compassionate grounds. In the said O.M. it has been clarified that the compassionate appointment can be made against the posts created under 5% of the vacant positions falling under DR quota only. Accordingly two vacancies were available, one each for year 2014 and 2015, for the position of Group 'C' post.

- 2. Instructions have also been issued that the compassionate appointment can be made by a committee consisting of three officers i.e. one Chairman and two members of the rank of Deputy Secretary/Director in the Ministry after assessing the suitability of all the applicants on the basis of financial position including pensionary benefits, liabilities, marital status, details about hardships etc. A person selected for appointment on compassionate grounds should be adjusted in the recruitment roster against his/her appropriate category i.e. SC/ST/OBC/General.
- 3. In view of the above instructions, a committee was constituted in the Ministry for making appointment on compassionate grounds against the Select List year 2014 and 2015. Following appointments were made:
