## Invitation of public comments

Sub: Proposal for grant of access permission to new retail outlet of M/s Nayara Energy Ltd (Formerly known as M/s Essar Oil Ltd) at Km 191+400 to 191+435 on NH-08 at Village-Devpura, Tehsil-Rajsamand & Distt-Rajsamand in the State of Rajasthan.

M/s Nayara Energy Ltd ie. the applicant vide letter No. EOL/UDO/DEVPURA/NH/01 dated NIL received in this office dated 02.02.2018 has submitted a proposal to this office on above captioned subject. PD PIU NHAI Udaipur has submitted his inspection report mentioning that that there exists a truck lay bye and a median opening in main carriageway at a distance of 186m (towards udaipur side) and at 219m (towards Gomati Chouraha) from the proposed fuel station, therefore oil company has proposed to construct 7.0m wide service road having length of 735m in between truck lay bye and fuel station with separator between main carriageway and proposed service road. PD PIU NHAI-Udaipur also mentions that Service road will be constructed and maintained by oil company at their own cost. Also undertaking for the same is appended with the proposal. Therefore this proposal may be considered through the extant policy of MoRTH and accordingly Public comments (if any) are invited.
