R/ Sir,

This in receipt of above referred letter of Ministry of Road Transport and Highways, Regional Office - Gandhinagar, whereas the proposal for Permission for laying 220 KV D/C overhead on D/C tower across Old NH-56 (NH-113) from Km. 231.913 to Km. 232.000 near village Nansalai Taluka Zalod, Dahod in the state of Gujarat, was received by this office to examine the said proposal in accordance with the Ministry's Guidelines no. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016. Afterwards, this office forwarded the proposal to the Authority's Engineer to inspect the site and to submit the comments with recommendation.

The Authority's Engineer has submitted their comments that the proposal is found in order of MoRTH Guidelines. Further, the Authority's Engineer has also furnished the specific comments, which are attached herewith for consideration and n/a please.

The following points are also be informed to the agency, prior execution of the work:-

- IRC 032: Standard for Vertical and Horizontal Clearances of Overhead Electric Power and Telecommunication Lines as Related to Roads, shall be complied strictly.
- If any amount/ demand is raised by the Authority in future, shall be deposited by the agency within the time frame.
- The Bank Guarantee for amounting to Rs. 1,00,000/- is to be deposited by the agency with NHAI, for which the user agency may be directed for compliance.
- The work shall be done under the Supervision of Authority's Engineer/ Contractor.
- The agency shall intimate to the Authority in written, prior execution of the work. No such work shall be done without informing to the Authority.
- All the safety measures have to be followed by the user agency during the execution of the work.

- The user agency shall ensure that no damage shall be occurred to the project highway at the time of execution of work and if it occurs, the repairing of the same shall be done at the cost of user agency.

In view of the above and upon recommendation of the AE, the proposal is herewith recommended with a request to issue the in-principle approval for laying 220 KV D/C overhead on D/C tower across Old NH-56 (NH-113) from Km. 231.913 to Km. 232.000 near village Nansalai Taluka Zalod, Dahod in the state of Gujarat.
