At the outset, we would like to thank you for your valuable time extended to us during our meeting on 03.04.18. As discussed during the meeting with regarding our application for laying of Vijayawada Dharmapuri Petroleum Product Pipeline parallel to NH 44 in the Utility Corridor. Wherein you have given valuable suggestion and requested us to submit us the revised drawings depicting both proposed Pipeline and OFC line for the entire length of 57.30 Km, Copy of Guidelines / Codal Provisions for safety of the pipeline laid near Highways (OISD-141) and also submission of copy of earlier project approval.

With regards to above we hereby submit the following documents:

1. 2 sets of Drawings depicting both proposed Pipeline and OFC line for the entire length of 57.30 Km.


2. Copy of Oil Industry Safety Directorate's Standard no. 141 clause no. 11.3.5 which states that "Pipelines located within 5 m from the road/highway right of way, shall be provided with higher wall thickness using design factor of 0.6. Also due consideration shall be paid in increasing the pipeline burial depth." **Accordingly, the design factor will be lowered to 0.6 from the 0.72(normal laying) and pipeline with higher wall thickness as per standard will be provided and also the minimum depth will be increased from 1.2 mtrs (minimum depth as per Standard) to 1.75 – 2.0 mtrs.,all along the length of the alignment in NH corridor.**

3. Copy of NHA's earlier approval for laying of Pipeline along NH utility corridor for **31 Kms** (NH- 15 between Km 217/000 to 186/000) by PIU, NHA-Palanpur is enclosed for your ready reference.

We request you to kindly approve our proposal so as to enable us to plan our subsequent activities as per the time schedule.
