## **Invitation of Public Comments**

Sub: NHAI, RO Chennai – PIU – Coimbatore – Six laning from Km 102.035 to Km 144.680 on the Chengapalli to start of Coimbatore Bypass and four laning from Km 170.880 to Km 183.010 on end of Coimbatore bypass to TN/Kerala Border section of NH-47 (New No.NH-544) – Indian Oil Corporation Limited – Request - Permission for laying of a Public Utility – "City Gas Distribution (CGD)" Pipeline and Optic fiber cable along the road Km 176/482 to Km 177/600 (LHS – 12.5 Inches), Km 177/200 to Km 177/600 (RHS – 12.5 Inches), Km 177/600 to Km 177/800 (LHS – 4.5 Inches) and across the road at Km 171/800, Km 173/200 and Km 177/600 in the Project Highway Chengapalli to Walayar (except Coimbatore Bypass) section of NH-544 - Approval Requested – Reg.

- 1. The proposal is regarding permission for laying The subject proposal pertains to proposed requesting permission for laying of RLNG pipeline of Public utility City Gas Distribution (CGD) Carbon steel pipe of 363 mm dia and HDPE duct pipeline of 40mm dia with OFC in NH-544 on (Salem Kochi road) for a length of 1718m length (1318 in LHS & 400 m in RHS) and 03 nos of crossings. The available width of ROW is 60m (30m + 30m) and it is proposed to lay the pipes of OFC on the utility corridor for a length of 1318 m in LHS and 400 m in RHS and 03 numbers crossing viz Km 176/482 to 177/600 (LHS-12.75 Inches), Km 177/600 to 177/800 (LHS-12.75 Inches), Km 177/200 to 177/600 (RHS-12.75 Inches) and 03 numbers of crossing at Km 171/800 (4.5 inch), Km 173/200 (4.5 inch) & Km 177/600 (12.75 inches).
- 2. DGM (PJ-CGD), M/s. IOCL, Coimbatore has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, If NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 60 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
