**Sub:** NHAI, PIU, Coimbatore - Rehabilitation and Up-gradation of NH-209 from km 123.550 to Km. 150.400 of Dindigul - Bangalore Road (Pollachi to Coimbatore Section) to four lane with paved shoulder in the State of Tamilnadu under NHDP-IV on EPC Basis - Requesting permission for laying of a public utility - City Gas Distribution (CGD) pipeline across NH-83 at highway chainage @ km 147/240 (Malumichampatti Junction)

1. The proposal is regarding permission for laying of public utility - City Gas Distribution (CGD)" pipeline across the National Highway NH-83 by HDD method at chainage km 147/240 (Malumichampatti Junction) for a length of 70 M by Indian Oil Corporation Limited, Coimbatore.
2. M/s. Indian Oil Corporation Limited, Coimbatore, has furnished an undertaking to accept any claims raised by the Authority, if any and the same will be paid by them and also furnished undertaking not to damage other utility, if damaged, then to pay the losses either to NHAI or to the concerned agency.
