Sub: NHAI - PIU, Salem - Permission for Erection of 110KVDC line from Thoppur 110 KV SS to Thoppur Railway Traction SS line across NH-7 of Salem - Dharmapuri in between Km 163/300 & 163/500 by the Executive Engineer, M/s Transmission Line Construction, Udayapatty, Salem - Approval requested - Reg

- 1). The subject proposal is requesting permission for Erection of 110KVDC line from Thoppur 110 KV SS to Thoppur Railway Traction SS line across NH-7 of Salem - Dharmapuri in between Km 163/300 & 163/500 in the project of Krishnagiri to Thumbipadi section of NH-7 in the State of Tamil Nadu.
- 2). The Executive Engineer, M/s Transmission Line Construction, Udayapatty, Salem has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
- 3). As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by the Executive Engineer, M/s Transmission Line Construction, Udayapatty, Salem will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
