Invitation of Public Comments

Sub.: Proposal for granting permission for laying of Underground 2 Nos. 33 KV, 3X300 sqmm XLPE Aluminium Armoured insulated cable along NH from KM 18.080 to KM 18.780 (LHS) NH-28 (New NH-27), Lucknow-Ayodhya Section, village Mohammadpur Chowki, Tehsil-Nawabganj & District-Barabanki in the State of Uttar Pradesh.

The Executive Engineer, Electricity Distribution Division, Madhyanchal Vidhyut Vitran Nigam Limited, Barabanki has submitted the proposal for granting permission for laying of Underground 2 Nos. 33 KV, 3X300 sqmm XLPE Aluminium Armoured insulated cable along NH from KM 18.080 to KM 18.780 (LHS), in the subject cited stretch.

2. From the submitted proposal, it is seen that the LHS ROW is 22.50m and RHS ROW is 22.50m from the centre line of the Highway. The HT cable is proposed to lay from KM 18.080 to KM 18.780 (LHS) along NH within available ROW. The Project at the utility laying location is 4-lane + service road and there is no utility land earthen/soft shoulder available. The HT Cable will be laid through HDD Method.

3. As per the guidelines, issued by the Ministry vide OM No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the Application shall be put out in the Public Domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

4. In view of the above, comments of the public on the above application is invited to the below mentioned address, which should reach by this office within 30 days from the date of publication beyond which no comments shall be entertained

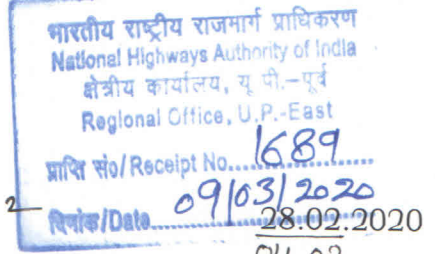
