#### Invitation of public comments

Sub.: Proposal for granting Permission for laying underground 63mm dia (HDPE) water supply pipe on Lucknow-Raebareli Section of NH-24B from KM 37.000 to KM 37.550, LHS & from KM 36.700 to KM 37.700, RHS and crossing at KM37.000 Nigoha, Block-Mohanlalganj, district-Lucknow in the State of Uttar Pradesh by UP Jal Nigam.

The Executive Engineer, Construction Division-II, UP Jal Nigam, Lucknow has submitted proposal for granting permission for underground laying/crossing 63mm dia HDPE water supply pipelaying at subject cited chainages/stretch through HDD method.

- 2. From the submitted proposal, it is seen that the utility is proposed to be laid along the NH from KM 37.000 to KM 37.550, LHS & from KM 36.700 to KM 37.700, RHS and crossing at KM 37.000 through trenchless (HDD) method and will be laid at the extreme edge of ROW. The width of ROW at crossing location is 26 28 M i.e. 13 14 M on LHS and 13 14 M on RHS. In this connection, UP Jal Nigam has confirmed that they will ensure all safety measures while executing the work.
- 3. As per the guidelines, issued by the Ministry vide OM No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the application shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
- 4. In view of the above, comments of the public on the above application is invited to the below mentioned address, which should reach by this office within 30 days from the date of publication beyond which no comments shall be entertained.


