Invitation of public comments

Sub: Proposal for grant of access permission to a new retail outlet of M/s HPCL at Km 323/186.3 to 323.221.3 (RHS) on NH-8 (NNH 48) (Udaipur to Ahmedabad road section) (Khasra No. 1441) at Village Parai, Tehsil- Sarada & District- Udaipur in the State of Rajasthan.

M/s HPCL ie. the applicant vide letter No.UDRO/AK/PARAI/UDAIPUR dated 24.12.2019 has submitted a proposal to this office on above captioned subject. The applicant has sought relaxation from Ministry Guidelines issued vide letter No. RW/ NH-33023/19/99-DO.III dated 24.07.2013. The proposal was forwarded to PD NHAI PIU Udaipur vide this office letter 21.01.2020 for comments and factual report. PD NHAI PIU Udaipur vide letter No.NHAI/UDR/NH-8/HPCL/R.O 323+186/2020/2314 dated 05.02.2020 has submitted the required report. There exists a intersection with rural roads/ approach roads to private and public properties at 161m as against 300m required as per MoRTH guidelines. However the proposed retail outlet proposal is submitted in this office on existing service road constructed by NHAI, therefore, this proposal may be considered through the extant policy of MoRTH and accordingly Public comments (if any) are invited.


