Invitation of public comments

**Subject:-** Permission proposal for laying of underground water supply pipe Line along the National Highways from Km 64/345 to 64/400(RHS), Km 64/400 to 65/450(LHS), Km 65/450-65/500(RHS), Km 66/050 -66/400, Km 66/550-66/700 & Km 66/740-66/827(LHS) and across the road at Km 64/400 Km 65/450, Km 66/050 and Km 67/892 of NH-49Extn (Madurai Cochin road)(new NH-No.85) for providing CWSS to 250 Rural Habitation in Kadamalaikundu-Mylandumparai-Andipatti & Theni Union in Theni District in the state of Tamil Nadu-Regarding.

The proposal is regarding request of permission for laying of underground water supply pipe line along the National Highways from Km 64/345 to 64/400(RHS), Km 64/400 to 65/450(LHS), Km 65/450-65/500(RHS), Km 66/050 -66/400, Km 66/550-66/700 & Km 66/740-66/827(LHS) and across the road at Km 64/400 Km 65/450, Km 66/050 and Km 67/892 of NH-49Extn (Madurai Cochin road)(new NH-No.85) for providing CWSS to 250 Rural Habitation in Kadamalaikundu-Mylandumparai-Andipatti & Theni Union in Theni District in the state of Tamil Nadu by the Executive Engineer, TWAD Board, RWS Division, Theni resubmitted to this office by the SE (NH), Madurai vide letter No. 1486/2022/DO dated 10.03.2023. The proposal has been examined and the details are as under:

2. The Right of Way in the stretch of NH proposed for laying underground water pipe line is varying from 25.10m to 40.00m. The carriageway width of stretch Km 64/345 to 64/400(RHS), Km 64/400 to 65/450(LHS), Km 65/450-65/500(RHS), Km 66/050 -66/400, Km 66/550-66/700 & Km 66/740-66/827(LHS) of NH-49Extn is 19.20m. The Executive Engineer, TWAD Board, RWS Division, Theni has proposed to lay the underground water pipe line at edge of the ROW for a length of 1742m by adopting open trench method along the National Highway and HDD method across the National Highway.

3. The Executive Engineer, TWAD Board, RWS Division, Theni has furnished an undertaking to the effect that they will remove the laid underground water pipe line in future if required by NH wing of State Highways Department, Tamil Nadu/MoRTH, Government of India at any time for expansion of the NH at their own cost without claiming any compensation from NH wing of Tamil Nadu/MoRTH, Government of India and any right on the NH land. Further, mentioned that, the Executive Engineer, TWAD Board, RWS Division, Theni will also restore the ROW surfaces to its original condition soon after removal of the Public utility water pipe lines. Also, certified that the proposed underground water pipeline work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.

4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016 the application will be made available for public comments and the comments will be invited within 30 days from the day of uploading the same in the web site of Ministry of Road Transport & Highways for public comments.
