The Roads and Building Department, Government of Gujarat vide letter cited under reference has recommended the subject cited proposal for laying of OFC of 24mm dia in HDPE protection pipe of 40mm dia with one spare HDPE 40mm duct of M/s. Telesonic Pvt Ltd along NH-56 from Km 356/900 to Km 421/200 of total length 64.300 Km and two crossing at Km 385/500 and Km 406/400 for approval of the Competent Authority.
