Invitation of Public Comments

Sub: Proposal for access permission for approach roads at km 388/002 to 388/037 (RHS) on NH-16 to the proposed Retail Outlet of Shri Mitu Behera (Applicant of BPCL) at Mouza-Daleiput, Tahasil-Khordha, Dist-Khordha in the state of Odisha-reg.

1. Shri Mitu Behera (applicant of BPCL), i.e., the applicant, vide letter dated 19.12.2019 has submitted a proposal to this office on the above mentioned subject. The applicant is requesting relaxation from Ministry's guideline issued vide letter no. RW/NH-33023/19/99-DO.III dated 24.07.2013 with respect to an "Intersection with Rural Roads/approach roads to private and public properties" is at a distance of 188 m as against the norm of minimum distance of 300 m and a "Gap in the central median from fuel station (for divided carriageway only)" is at a distance of 228 m as against the norm of minimum distance of 300 m.
2. As per Ministry's OM No. RW/NH/33023/19/99/DO-III dated 16.03.2016, the Highway Administrator will make available the relaxation proposal along with Form-A on the Ministry's website (morth.nic.in) to invite public comments, for a period of 60 days.
3. In view of the above, comments of public, if any, on the above relaxation proposal are invited online as well as in hard copy by enclosing location plan, justification & Form-A. The same should reach to the below mentioned address within 60 days from the date of uploading it, in the website, beyond which no objection will be considered.
