Invitation of public comments

Subject:- Permission proposal for laying of underground water supply pipe line along the National Highways from Km 55/300 to 56/580, Km 56/800 to 58/800 & Km 59/000 to 59/600(RHS) of NH-49Extn (Madurai Cochin road)(New NH-No.85) for providing CWSS to 250 Rural Habitation in Kadamalaikundu-Mylandumparai-Andipatti & Theni Union in Theni District in the state of Tamil Nadu-Reg.

The proposal is regarding request of permission for laying of underground water supply pipe line along the National Highways from Km 55/300 to 56/580, Km 56/800 to 58/800 & Km 59/000 to 59/600(RHS) of NH-49Extn (Madurai Cochin road)(New NH-No.85) for providing CWSS to 250 Rural Habitation in Kadamalaikundu-Mylandumparai-Andipatti & Theni Union in Theni District in the state of Tamil Nadu by the Executive Engineer(A/C), TWAD Board, RWS Division, Theni resubmitted to this office by the SE (NH), Madurai vide letter No. 578/2022/DO dated 10.03.2023. The proposal has been examined and the details are as under:

2. The Right of Way in the stretch of NH proposed for laying underground water pipe line is varying from 15.00m to 26.00m. The carriageway width of stretch from Km 55/300 to 56/580, Km 56/800 to 58/800 & Km 59/000 to 59/600(RHS) of NH-49 Extn(New NH-85) is 10.00m. The Executive Engineer(A/C), TWAD Board, RWS Division, Theni has proposed to lay the underground water pipe line at edge of the ROW for a length of 3880m by adopting open trench method along the National Highway.

3. The Executive Engineer (A/C), TWAD Board, RWS Division, Theni has furnished an undertaking to the effect that they will remove the laid underground water pipe line in future if required by NH wing of State Highways Department, Tamil Nadu/MoRTH, Government of India at any time for expansion of the NH at their own cost without claiming any compensation from NH wing of Tamil Nadu/MoRTH, Government of India and any right on the NH land. Further, mentioned that, the Executive Engineer (A/C), TWAD Board, RWS Division, Theni will also restore the ROW surfaces to its original condition soon after removal of the Public utility water pipe lines. Also, certified that the proposed underground water pipeline work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.
