Subject: Permission for overhead crossing of 220KV D/C Asoj-IOCL line between LOC o. 22.0 & LOC No. 23.00 between km 99/150 to km 99/100, km stone Ahmedabad-100, Vadodara-10, and Ahmedabad-99, Vadodara -11 on Ahmedabad-Vadodara section of NH-48(Old NH-8)

The proposal is regarding permission for erection of 220KV overhead electric line crossing from km 99/150 to km 99/100 of NH-48 (old NH-8) was submitted to this office by the Project Director NHAI, PIU Ahmedabad vide No. NHAIPIU-Ahmedabad/NH-8/Per/03/2019/1312 dated 22.05.2019 for approval of Highway Administration.
