Invitation of public comments

Subject:- Permission proposal for laying underground water pipeline along the road from Km 5/800- 10/050(LHS), Km 10/660-13/860(RHS), Km 12/340 to 18/770(LHS), & crossing at Km 8/130, Km 9/162, Km 9/222, Km 10/660, Km 12/340, Km 12/400, Km 13/820, Km 13/860, Km 13/900, Km 14/730, Km 16/610, Km 17/560 and Km 18/770 of NH-383Extn (Kottamapatti-Thiruppathur Road) between Anaikaraipatti and Maruthipatti for providing CWSS to 8 Town panchayaths and 2452 Rural Habitations in 11 unions with bulk provision to 3 Municipalities in Sivagangai District in the state of Tamil Nadu -Regarding.

The proposal is regarding request for permission for laying underground water pipeline along the road from Km 5/800- 10/050(LHS), Km 10/660-13/860(RHS), Km 12/340 to 18/770(LHS), & crossing at Km 8/130, Km 9/162, Km 9/222, Km 10/660, Km 12/340, Km 12/400, Km 13/820, Km 13/860, Km 13/900, Km 14/730, Km 16/610, Km 17/560 and Km 18/770 of NH-383Extn (Kottamapatti-Thiruppathur Road) between Anaikaraipatti and Maruthipatti in the state of Tamil Nadu by the Executive Engineer, TWAD Board, Project Division, Karaikudi submitted to this office by the SE (NH), Madurai vide letter No. 325/2021/JDO dated 07.03.2022(received on 16.03.2022). The proposal has been examined and the details are as under:

2. The Right of Way in the stretch of NH proposed for laying water pipeline is varying from 12.00m to 35.20m. The carriageway width of stretch from Km 5/800- 10/050(LHS), Km 10/660- 13/860(RHS), Km 12/340 to 18/770(LHS), of NH- 383Extn is 10.00m. The Executive Engineer, TWAD Board, Project Division, Karaikudi, has proposed to lay the underground Utility of NH- 383Extn at edge of the ROW for a length of 13880m by adopting open trench method along the National Highway and HDD method across the National Highway.

3. The Executive Engineer, TWAD Board, Project Division, Karaikudi, has furnished an undertaking to the effect that they will remove the laid Public Utility water pipeline in future if required by NH wing of State Highways Department, Tamil Nadu/MoRTH, Government of India at any time for expansion of the NH at their own cost without claiming any compensation from NH wing of Tamil Nadu/MoRTH, Government of India and any right on the NH land. Further, mentioned that, the Executive Engineer, TWAD Board, Project Division, Karaikudi, will also restore the ROW surfaces to its original condition soon after removal of the Public utility water pipelines. Also, certified that the proposed Public Utility work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.

4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016 the application will be made available for public comments and the comments will be invited within 30 days from the day of uploading the same in the web site of Ministry of Road Transport & Highways for public comments.
