4. We had made preparation for commencement of work, but our dealer is suffering from terminal illness and needs frequent hospitalization. This has hampered the progress of land development for the approach road. But we have sorted out the problem and currently the work is in progress.

In view of the above, you are requested to kindly consider and give us one-year time extension for completion of the work as per your approval. We assure you that we will definitely meet the timelines and complete all the work as per the approved plan.
