(DIT Mantralaya) proposal for laying Telecom OFC in stretches from Km.435.800 to Km. 458.500 (Length 25.30 Km) on NH-3 - Reg.

Maharashtra Information Technology Corporation Ltd. (DIT Mantralaya) vide letter cited above, has submitted the proposal for laying underground OFC cable along ROW of NH-3 (Pimpalgaon-Nashik-Gonde & Vadape-Gonde) Section of NH-3 for approval of the Competent Authority, Highway Administration.

- 2. From the submitted proposal, it is observed that, the laying underground OFC cable is proposed along ROW of NH-3 (Pimpalgaon-Nashik-Gonde & Vadape-Gonde) Section from Km.435.800 to Km. 458.500 (Length 25.30 Km).
