Sub: NHAI-PIU-NSK- Widening of existing 2 lane carriage way to 4/6 lane carriageway configuration for Dhule - Pimpalgaon (Km 265.00 to Km 380.00) section of NH-3 in the State of Maharashtra - M/s. Telesonic Network Ltd.'s (Airtel) proposal for laying OFC in stretches from Km. 303.800 to Km. 310.400 (Length 6.6 Km) on NH-3 - Reg.

M/s. Telesonic Network Ltd.'s (Airtel) vide letter cited above has submitted proposal for laying underground OFC cable along ROW of NH-3 (Dhule-Pimpalgaon) Section of NH-3 for approval of the Competent Authority, Highway Administration.

2. From the submitted proposal, it is observed that, the laying underground OFC cable is proposed along ROW of NH-3 (Dhule-Pimpalgaon) Section from Km. 310.400 to Km. 303.800 (Length 6.6 Km).

3. As per Para-4 of Ministry Circular No. RW/NH-33044/29/2015/S&R(R), Dtd. 22.11.2016, the Highway Administration shall put out in the Public Domain for 30 days for seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
