- ii. It is to mention that , instant section of NH-953 falls under Hilly/mountainous terrain and got very limited ROW (15 to 18 mt) and the carriageway. To ensure the protection of the main carriageways/side shoulder and proper restoration of the trenches in ROW an additional 100 % performance (76,30,300+7630300) has been requested by the Highway Administration.
- iii. The receipt of online license fee deposition should be submitted to this office with intimation to the Executive Engineer, NH- Division, Bharuch. The BG should be in favor of the Executive Engineer, NH- Division, Bharuch (as per prevailing procedure in R&B Dept.) and to be submitted to Executive Engineer, NH- Division , Bharuch custodian of BG/s.
