The proposal is regarding request for permission for laying of CBR-Asanur Petroleum product pipeline along with underground Optical Fiber Cable (OFC) the NH across at Chainage Km 63/534 of NH- 532 of in the State of Tamil Nadu by M/s Indian Oil Corporation Ltd., Southern Region Pipelines, submitted to this office by the SE (NH), Chennai vide letter No. 537/2023/AE-I/NH dated 13.04.2023. The proposal has been examined and the details are as under:

Across - Km 63/534	Size of Pipe 24" D	Main line pipe 98mm OD sch.80Ms pipe , 40mm HDPE pipe & 20mm OFC Cable

2. The Right of Way in the stretch of NH proposed for laying underground cable line is 24.50m. The carriageway width of stretch at Km 63/534 of NH-532 is 10.00m. M/s IOCL, has proposed to lay the R-LNG pipeline at the edge of the ROW. Further, M/s IOCL, has mentioned that the R-LNG pipeline along with underground Optical Cable proposed to lay by **Trenchless method** at a depth of 7.00m from the bottom of the road.

3. As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016 the application will be made available for public comments and the comments will be invited within 30 days from the day of uploading the same in the web site of Ministry of Road Transport & Highways for public comments.
