

## PROCEEDING OF GOVERNMENT OF KARNATAKA

**Subject:** "Registered Vehicle Scrapping Policy" (RVSP) Scheme 2022 to scrap old vehicles in the State of Karnataka - Reg.

**Reference:** 1. Government Order No. TD 191 TDO 2022, Dated:30-12-2021.

### **Proposal:**

In the order read at above (1), eligible vehicles in the State as per the criteria laid down vide Central Ministry of Road Transport and Highways Notification No. GSR 653(E), dated:23.09.2023, GSR 695 (E), dated:03.09.2022 and orders issued from time to time. In order to implement the Registered Vehicle Scrapping Policy, 2022 as approved in Cabinet Case No:C729/2022, dated:22.12.2022, an order is issued to implement the said policy.

Rule 52-A of the Central Motor Vehicles Rules, 1989 prohibits renewal of registration certificates of Government/Corporations/Boards vehicles of more than 15 years and such vehicles are to be compulsorily scrapped.

With regard to scrapping of registered vehicles which are more than 15 years old owned by the Government / Corporation / Boards etc., Notification No: GSR 29 (E ) dated 16.01.2023 has been issued by the Central Government and in the Guidelines of the Central Government Scheme for Special Assistance to States for Capital Investment 2022-23, with regard to grant of one time waiver of pending liability on old vehicles scrapped at RVSF for at-least one year.

In the letter No: F.No.44(1) PF-S/2023-24 (CAPEX) dated 03.02.2023 of the Ministry of Road Transport and Highways has announced "Guidelines on the Scheme for Special Assistance to States for Capital Investment 2023-24 and in the letter No: F.No.44(1) PF-S/2023-24 (CAPEX) dated 02.05.2023, incentives have been fixed up to Rs.200.00 Crores from the Central Government for scrapping of old vehicles. For the State Governments to be eligible to avail the said incentives Milestone-1 and Milestone-2 have to be achieved. Accordingly, in Milestone-1, below mentioned three targets have been fixed.

1. Issue of Government order to scrap all Government owned vehicles which are older than 15 years at Registered Vehicle Scrapping Facilities (RVSF). State Government order shall clearly indicate the

expected number of vehicles across all Departments/Local Bodies/Undertakings etc. which would be scrapped and timeline by when they would be disposed through RVSFs.

2. Grant of Motor Vehicles (MV) tax concession on new vehicles registered against Certificate of Deposit (CoD).
3. Grant of one- time waiver of pending liability on old vehicles scrapped at RVSF for at-least one year.

In Milestone-2, below mentioned target has been fixed.

Scrapping of all Government, and all Departments/Local Bodies/Undertakings etc., vehicles which are older than 15 years as per the criteria fixed in the notification.

Accordingly, if the State Government achieves the targets notified in Milestone-I, State will get Incentive Aid of Rs. 100.00 Crores from the Central Government. In Milestone-1, the target mentioned at Sl. No. (2) - Grant of Motor Vehicles (MV) Tax concession on new vehicles registered against Certificate of Deposit (CoD) has been achieved, there is necessity of completing the remaining 02 targets.

Accordingly, in order to compulsorily scrap all the vehicles owned by the Government/ Corporations/Boards etc which have completed 15 years and if the owners of private vehicles voluntarily intends to scrap their vehicles, this proposal is submitted providing exemption/waiver from the cases registered against it from the transport department (DSA Case Fines) and Traffic Violation Cases registered from Police Department, for the last 01 year from the date of scrapping, from payment of said fines. The Commissioner, Transport and Road Safety has submitted a proposal to the Government read at above (2) seeking approval of the Government to grant exemption from levy of fines, limited to cases registered under Violation.

The said proposal submitted by the Commissioner, Transport and Road Safety, is examined and ordered as follows:

In view of the points explained in the proposal, approval is accorded to implement the "Registered Vehicles Scrapping Policy, 2022" to scrap old vehicles in the State of Karnataka, 5000 vehicles belonging to the State Government/ Central Government/ Governmental Institutions/ Corporations/ Boards/ Local Bodies/ etc. which have completed 15 years can be scrapped based on priority and utility in a phased manner. First priority should be given to scrapping vehicles that have completed maximum number of years.

Further ordered that the vehicles which are intended to be scrapped by the general public voluntarily, exemption is applicable only for one year from the date of issue of this order, from recovery of penalties in respect of cases against it under the statutes of Transport Department (DSA Case Fines) and also in respect of cases filed by Police Department for traffic violation for the last one year.

This order has been issued as per the concurrence given by the Finance Department vide Note No: FD 418 Exp-11/2022 (E), dated: 04-09-2023 and as approved vide Cabinet Case No: C:468/2023, dated: 22.09.2023.
