The proposal of M/s. IOCL, for issue of NOC to NH access permission to New Retail Outlet abutting on LHS boundary of NH -150A (Jewargi - Chamarajanagar section) at Km 69.043 in Sy. No. 45/3 of Kavadinatti (Shorapur City Municipal limit) village, Shorapur Hobli, Shorapur Taluk, Yadgir District, Karnataka State, was forwarded by the Executive Engineer, NH Division, Kalaburgi vide letter no. EE:NHD:KLB:PB-3:Retail Outlet:NOC:2018-19:295 dated 19.06.2018 to this office. The proposal was examined and in-principle approval was accorded vide this office letter of even no. dated 10.08.2018 (Annexure I). The Oil company M/s. IOCL, Bellary vide letter No. BLY/R/YDR/Shorapur Town dated 03.07.2019 (Annexure II), has sought extension of NOC for a further period of one year. The Executive Engineer, NH Division, Kalaburgi vide letter No. EE:NHD:KLB:PB-3:Retail Outlet-EOT:2019-20:555 dated 23.07.2019 has recommended the EOT proposal (Annexure III). The justification is enclosed as Annexure IV.

2 As per Ministry vide OM No.RW/NH/33023/19/99-DO.III dated 16.03.2016, the Highway Administrator will make available the relaxation proposal of Oil company for public comments, and the comments will be invited within 60 days from the day of uploading.

Sir,

Please refer to EE, NH Division, Kalaburagi letter cited under reference (ii) submitting there with above mentioned proposal. Further, license fee amounting to ₹2,50,000/- is submitted by M/s. IOCL vide letter cited under reference (i). The proposal is examined in the light of details furnished therein and Certification of the proposal by EE, NH Division, Kalaburagi enclosed therewith. "In-principle" approval is accorded for the above proposal (for access permission) and a provisional NOC is issued subject to following conditions:

- (i) The Oil Company/ Owner of the retail outlet mentioned in the subject shall construct the access as per approved drawings at their own cost within 6 (six) months of the issue of this Provisional NOC. On completion of the construction in accordance with the checklist and conforming to the approval, a Completion Certificate would be issued by concerned EE of NH Division / Project Director about the completion of construction work and thereafter License Deed would be signed by the Regional Officer, Bengaluru. In case, the construction is not done in one year, the provisional approval shall be deemed to be cancelled, unless renewed by the Highway Administration.
- (ii) The applicant shall strictly adhere to the undertakings given with the proposal in compliance to Sl.No 7 to 10 of Annexure -I (To Appendix-I) enclosed with Ministry's letter No. RW/NH-33023/19/99-DOIII dated 24th July, 2013. It shall be ensured by EE of NH Division / PD, NHAI that the undertakings made by the applicant are complied with in all respects. Any discrepancy would lead to violation of the Ministry's guidelines and the approval accorded shall stand cancelled.
- (iii) The concerned EE of NH Division / Project Director shall examine the road safety conditions during/ consequent to construction of approaches. In case of any adverse conditions, the matter may be reported to this office. Compliance to the approved drawings and other conditions are to be ensured by them.

- (iv) After obtaining "in-principle" approval, the oil company/ owner of the retail outlet shall be responsible for construction and maintenance of acceleration/deceleration lanes, service lanes, channelizers, drainage arrangement in accordance with the approved drawing/lay out plan and specification conforming to the norms at his own cost.
- (v) In case of noticing of defaults/ deviations if any during inspections would lead to cancellation of the approval accorded for access permission.
- (vi) The construction of the retail outlet and its allied works shall be carried out as per the approved drawing. Any deviation from the approved drawing is not acceptable.
- (vii) It must be ensured that drinking water and toilet facilities are available at proposed fuel station and a display board showing such facilities shall be installed before entry to the fuel station.
- (viii) The applicant/oil company is responsible for the correctness of land documents, land conversion order, survey numbers and schedules mentioned in the land documents and license agreement enclosed with the proposal.

Adverting to above cited subject, under the reference letter (1) a provisional NOC has been issued for new MS/HSD retail outlet abutting on LHS boundary on NH-150A (Jewargi-Chamrajanagar section) at km 69.043 in Sy No:45/3 of Kavadinatti (Shorapur city Municipal limits), Shorapur Hobli, Shorapur taluk Yadgir district with a condition to construct the access within six months from the issue of provisional NOC and thereafter licensee deed would be signed by the Regional Officer within a year, otherwise the provisional approval shall be deemed to be cancelled.

The provisional NOC was issued on 10.08.2018 and the oil company would have completed the access within 09.02.2019. The same has not been commenced by the oil company. The oil company in letter dated 03.07.2019 has stated that the NOC for

the said outlet was delayed and finally they had received NOC from DC Yadga on 02.01.2019 (copy enclosed). In view of this delay and in view of delay in processing tender for construction of new outlet by the oil company, they have sought extension of time for the provisional NOC for further one year i.e from 10.02.2019 to 09.02.2020. The request of the oil company may kindly be considered and the validity of provisional NOC for construction of access road may kindly be extended for further period of one year from 10.02.2019 to 09.02.2020.
