With reference to above subject, the Permission for laying of underground R-LNG gas pipeline along with OFC cable across NH 207 at Km 17.683, Km 22.476 & Km 35.248 by M/s Indian Oil Corporation Ltd., through HDD method has been accorded with a direction to deposit License fee by the Chief Engineer-Regional Officer, MoRTH, Bengaluru vide letter cited at ref(1).

Further, M/s Indian Oil Corporation Ltd, Bengaluru has deposited License fee for only two crossings at Km 22.476 & Km 35.248 according, permission has been accorded for two crossings by the Chief Engineer-Regional Officer, MoRTH, Bengaluru vide letter cited at ref(2).

Now, IOCL's pipeline has planned further to connected to GAIL SV station for which said pipeline will cross the NH-207 at Km 17.683. M/s Indian Oil Corporation Ltd, Bengaluru has submitted request to accord permission for laying underground natural gas pipeline along with OFC at Km 17.683 by HDD method.

The Assistant Executive Engineer, NH sub division, Bengaluru has verified the proposal in accordance with the norms laid down by the Ministry's circular no.RW/NH-

33044/29/2015/S&R(R) dated 22nd November 2016 and submitted the proposal vide letter under ref (3).

M/s Indian Oil Corporation Ltd has submitted necessary check list, drawings with ROW, distance of the cable is being laid from the centreline of the carriage way and cross sections.

Hence, the proposal for laying of underground R-LNG gas pipeline along with OFC cable across NH 207 at Km 17.683 by HDD method is here with submitted for obtaining permission from the competent Authority
