1. Shri Sanatan Chakroborty (applicant of BPCL), i.e., the applicant, vide letter dated 18.10.2019 has submitted a proposal to this office on the above mentioned subject. The applicant is requesting relaxation from Ministry's guideline issued vide letter no. RW/NH-33023/19/99-DO.III dated 24.07.2013 with respect to "intersection with rural roads/ approach roads to private and public properties" which is at a distance of 216 m against the norm of 300 m.
2. As per Ministry's OM No. RW/NH/33023/19/99/DO-III dated 16.03.2016, the Highway Administrator will make available the relaxation proposal along with Form-A on the Ministry's website (morth.nic.in) to public comments for a period of 60 days.
3. In view of the above, comments of the public, if any, on the above relaxation proposal are invited online as well as in hard copy by enclosing location plan, justification & Form-A. The same should reach to the below mentioned address within 60 days from the date of uploading it in the website, beyond which no objection will be considered.
